In consideration of the use of the Fruita Outdoor Pool, the Renter also agrees:

- A. To abide by all Swimming Pool rules and all rules, regulations, and ordinances of the City of Fruita, as well as those in attendance for the use noted above;
- B. To NOT allow smoking or alcohol inside the pool area or in any area by any person in attendance;
- C. To make sure all attendees confine themselves to the pool area, concession area and restrooms ONLY;
- D. To be responsible for all setting up of the table/eating area and returning it to its original condition;
- E. To limit food and drink use to the concession area only;
- F. To cancel at least one (1) week in advance in order to have portion of fees reimbursed;
- G. No damage of any kind or description will be committed upon the facility or any of its contents by any person(s) in attendance, and that the undersigned person(s) will hold harmless and indemnify the City of Fruita for any person(s), whose property may be within the building, for loss or damage to such property caused by any person(s) in attendance for the use noted above, or for any damage or injury arising by reasons for the use noted above.
