I understand the risks and dangers inherent with the activities in which I will be participating and acknowledge that I am fully capable of participating in these activities. I am in good health with no defects that would prevent me from engaging in these activities and I willingly assume the risk of injury as my sole responsibility. I understand and agree that any bodily injury, death, or loss of personal property and expense as a result of my negligence, or the negligence of the City, are my responsibility. As lawful consideration for being permitted to participate in the above activities, I release from any legal liability and agree not to sue, file claim against the property of, or prosecute; and to indemnify and hold harmless, the City of Fruita and all of its officers, agents and employees for any and all liability, injury, or death caused by or resulting from my voluntary participation in the activities mentioned above; whether or not such liability injury or death was caused by their negligence, or by my negligence, or any other cause. This Waiver and Release of Liability shall be legally binding upon me, my heirs, my estates, assigns, legal guardians and my personal representatives. I have carefully read the Release and fully understand its contents. I am aware that I am releasing my legal rights that I otherwise may have and I enter into this agreement of my own free will, and with full understanding and awareness of the risks involved. I agree to assume such risks.

I authorize and consent to the publication of myself, or minor, whether by television, newsprint, written advertisements or otherwise, of any materials contained in my name or picture for participation in any event.

## City of Fruita Parks and Recreation Player Code of Conduct

---

The following "Player Code of Conduct" has been adopted by the Fruita Parks and Recreation Department. These rules of conduct will apply to all players and managers during practices and games. Team Managers are responsible for the conduct of his/her team and fans.

1. No player shall; at any time lay a hand upon, shove, or threaten to strike an official, Fruita Parks and Recreation staff, or other player.
2. No player shall; be guilty of a physical attack upon any player, official, spectator, or scorekeeper.
3. No player shall; discuss with an official, in any matter, the decision reached by such official, except the manager or captain.
4. No player shall; be guilty of unnecessary rough tactics in the play of the game against the body of any opposing player.
5. No player shall; appear upon the field, or play at any time in an intoxicated condition.
6. No player shall; use profane, obscene, or vulgar language in any manner, or at any time during the game.
7. No player shall; taunt any members of the opposing team.

Minimum penalty for all infractions: Official is required to immediately suspend player(s) from further play and report such player to the league director. Suspended players are required to leave the facility immediately. (Out of sight, out of sound) Failure to do so will result in further suspension. Player(s) will remain suspended until his/her case has been considered.

Penalties for failing to comply with the player code of conduct will result in the withdrawal of the privileges of participation in the Fruita Parks and Recreation Department's activities, either by immediate suspension for a specified time or indefinitely.

The League Director has full discretion of imposing penalties on all violations of the Players Code of Conduct. In any violation not included in the said code, the penalty shall be at the discretion of the League Director.
