# **Update on Pine Gulch Fire**

The Pine Gulch Fire, located 18 miles north of Grand Junction, has continued to be very active this week. The fire started last Friday when lighting struck the area. As of Thursday night, it is estimated that the fire is at 12,608 acres and is 5% contained. There are over 300 firefighters from several different organizations working to get the fire contained. For the latest information, there has been a Facebook page created just for the fire, and it can be found at this <u>link</u>. Thank you to everyone is working to put this fire out and keeping our communities safe. We will continue to keep you updated on this.

# **Coronavirus Update**

- Virtual Q&A. Next Tuesday morning, the Fruita Chamber is hosting a virtual Q&A with Mesa County Public Health Executive Director Jeff Kuhr and our Planning and Development Director Dan Caris. Jeff Kuhr will be answering questions to help businesses understand current COVID restrictions and guidelines, and Dan will be providing an update on upcoming projects in Fruita to help businesses. The meeting will be held via Zoom, and you can find more information and register here.
- CHSAA Announces Athletics Calendar. On Tuesday, the Colorado High School Activities Association announced its 2020-2021 athletics and activities calendar. The only sports that will be held this fall are Cross Country, Boys Golf, Boys Tennis, and Softball. All other fall sports have been moved to next year. Also, each season is approximately seven weeks from start to finish, and season competition and postseasons has been reduced. - Northwest Region DOLA Meeting on COVID-19. On Thursday, staff attended a virtual meeting with the Department of Local Affairs Leadership and members of the Governor's COVID-19 Response Team to receive an update on the state's response to the virus. These division meetings will be ongoing and elected officials are encouraged to attend and ask questions. A few highlights from the meeting is that

- Grand Valley Task Force Meeting. The Grand Valley Task Force, which Councilman Harvey is a
  part of, will have its next meeting at the Fruita Community Center next Thursday (August 13)
  from 6:00 p.m. to 8:00 p.m. The Task Force was recently formed to address issues of inequality,
  and is comprised of community leaders, elected officials, social advocacy representatives, and
  members of the police.
- Great American Outdoors Act. This week, President Trump signed the Great American
  Outdoors Act. The act funds the Land Water Conservation Fund ('LWCF") and provides
  additional funding for maintenance for national parks. More information can be found <a href="here">here</a>. In
  the past, the Council has supported and requested our federal representatives to fully fund the
  LWCF.

## **Parks and Recreation**

- Fruita Community Center staff is planning to close the indoor pool starting on August 24<sup>th</sup>, or two weeks prior to the scheduled closure on September 7<sup>th</sup>, to repair and replaster the pool. The outdoor pool will remain open and available until the indoor pool is ready to reopen in late September. The additional two weeks of indoor pool closure will provide personnel, chemical and water cost savings, but will also allow us to make necessary repairs to the pool.
- Mesa County Public Health has applied for a GOCO Resilient Communities grant to fund a trails
  maintenance crew for the Fall and next year. The crew will perform additional maintenance on
  trails that have been degraded due to the increased usage as a result of COVID, i.e. people
  increasing participation or (re)discovering outdoor recreation. The City of Fruita, along with
  COPMOBA, BLM, our local businesses and the City of Grand Junction have all provided varying
  grant matches (in-kind or financial) and letters of support.
- The Fruita youth Action Council is kicking off their 2020/21 year with a retreat this coming Monday, August 10<sup>th</sup>. With 6 new members, FYAC will do some team building exercises and then discuss the upcoming years goals and activities. We are excited that we have 20 interested and engage youth on FYAC this year.
