Tuesday's City Council Meeting

We've got a full agenda for the meeting on Tuesday night. Our meeting will begin with a Proclamation declaring October as "Random Acts of Kindness Month" in Fruita. Following that, there are eight items on the consent agenda. There are no legislative hearings currently on the agenda, but six quasi-judicial hearing items regarding a liquor license application, several special events, and the outdoor seating areas. During my report, I will cover the draft 2020 2022 Action Items summary to get your feedback. We will conclude our meeting with rescheduling our workshop this month to the fifth Tuesday, where we will discuss the budget. As a reminder, this meeting will be virtual.

This week, we launched the Be Well, Be Fruita campaign. This campaign is an effort to continue upon the incredible progress that we have made as a community against COVID-19, to support and keep our businesses open, to assist our schools with safe, outdoor learning spaces, and to strive to keep our families, friends, and neighbors safe, now and in the future. Coronavirus Update

Below are a few updates, but I would strongly encourage all to continue to follow www.fruita.org/covid19 for all updates we are posting. This also links to important Mesa County Public Health sources, as well as many others.

- Mesa County Approved for Protect our Neighbors Phase. On Tuesday, Mesa County Public Health (MCPH) received approval to enter the Protect our Neighbors phase of the state's reopening plan. This approval allows MCPH and the Mesa County Board of Health to draft and approve a local public health order which will continue the phased reopening of our community. Although this new phase has been approved, it has not been implemented locally. We will provide more information as it becomes available. - Outbreak Map Released. The Colorado Department of Public Health and Environment
 ("CDPHE") launched an outbreak map on the COVID-19 website this week. This outbreak map
 displays the location of all confirmed outbreaks reported to CDPHE and is updated each
 Wednesday. If interested, the map and data can be found here. As you can see, there has been
 a few outbreaks in Mesa County, but none reported in Fruita so far.
- Free Community COVID-19 Testing. As we reported last week, MCPH is now offering free COVID-19 testing without an appointment at the Mesa County Fairgrounds. The community sampling site is open from Tuesday through Saturday from 8:00 a.m. to 3:00 p.m. Preregistration is recommended but not required, a link can be found https://example.com/here. Testing turnaround times have improved to 2-3 days!
- More Event Cancellations. Last week, we reported that the Rim Rock Run has been cancelled, and this week, we were informed that the Co2Ut Race (the gravel race scheduled originally for early October) has been postponed as well. The race has been rescheduled to April 24, 2021. For more information can be found at the Desert Gravel website <a href="https://example.com/here-new-market-new-marke
- Coronavirus Relief Funds. We continue to make headway on eligible expenses. The downtown spaces are in progress and we hope they will be complete next week to open the following week. We are working on a fun way to open them, ground rules and information to assist our local businesses with utilizing them. Tuesday night you have two resolutions to assist with these as well. One will enable the fenced area of the spaces to allow "to-go" alcohol per the state rules to be consumed within, without the businesses having to alter their liquor licenses. Outdoor classrooms are designed for each Fruita school and ordering of materials is beginning. We are evaluating needs at Fruita foodbanks.

Remembering 9/11/2001

Today and every day, we remember all of those that were lost on September 11, 2001. We want to thank all the brave first responders who risked their lives on that day and those that continue to keep us safe every day.



General Updates

- Financial Update. In July, almost all tax revenues were up when compared to the previous year. City sales tax was up 46.81% from the previous July (YTD is up 28.50%), use tax on motor vehicles was up 32% (-7% YTD), use tax on building materials was up 121% (YTD 16%), and County sales tax was up 8% (YTD 4% increase over 2019). Unfortunately, the lodging tax continues to be impacted by the COVID-19 pandemic but did show some improvements compared to previous months. July lodging tax was down 27 % compared to July 2019 (YTD is down 47.5%).
- **Pine Gulch Fire.** With all of the rain and precipitation that we received this week, the Pine Gulch Fire is nearly concluded, and operations are beginning to wind down. For the second straight week, there has been no growth (still at 139,007 acres) and crews have begun repair work throughout the fire area. The fire is 95% contained, and the number of personnel working on the fire has decreased significantly. This morning, the Bureau of Land Management ("BLM") reported changes to the area closure order and public lands are now open. The closure area has been reduced and now only includes the fire area depicted on the map at this <u>link</u>. A few highlights from the updated order are:
 - The North Fruita Desert (18 Road) campground and trails are open, including the Sarlaac Trail. Skywalker trail is closed.
 - The Edge Loop is open to the fire edge, but BLM recommends users turn around at the mouth of Lippan Wash.
 - County Road 256 east of Douglas Pass is open
 - Winter Flats Road (Mesa County V 2/10) is open.
 - The updated closure order can be found here.
- **Fruita for Equality Event.** One last reminder, tomorrow at Civic Center Park, Fruita for Equality is hosting an open house discussion on the topics of equality, race, and prejudice in the

- community. The event is at 4:30 p.m. tomorrow, and is hosted by Mesa County Libraries, the Fruita Rotary Club, and Lithic Bookstore. The flyer can be found below.
- *Online Variety Show.* The Cavalcade's Online Monthly Variety Show continues this Saturday at 7:30 p.m. The show will be hosted at both the <u>Cavalcade's Facebook page</u> and their website here.
- **Red Baron Ball.** For the first time, the Family Health West Foundation is hosting the Red Barron Ball virtually. The annual event supports the pediatric programs at Family Health West. To reserve your virtual seat, you can visit this <u>link</u>. The event is free to attend and you can watch it from anywhere.

Engineering

- There were 3 responses to the 2nd round of concrete replacements with Professional Pipeline Concrete, Inc with the lowest bid a \$10,680.
- The Active Circulation Plan submittals are under review with an anticipation of selecting a consultant next week.

Parks and Recreation

- Mesa County Public Health was officially awarded a GOCO Resilient Communities grant application to fund a trails maintenance crew starting this Fall. The City of Fruita provided \$5,000 of cash match for the project as a letter of support. The total project is \$190,000 and will fund the crew for the next several seasons and is a great start to getting many of our local trails maintained, especially after the heavy visitation we have had at the 18 Road and Kokopelli trails systems this year apparently there is no better way to beat COVID that to recreate outside!
- Demo work is more or less complete with the indoor pool at the FCC see attached pictures. The plan is still to start replastering next week and reopening the week after.


