Re: WEEKLY INFORMATION UPDATE

Next week's City Council Meetings

We have two City Council meetings scheduled for next week. The first, a joint meeting with the Parks and Recreation Advisory Board, will be on Monday night at 5:30 p.m. and will be held virtually. We will be discussing the Parks, Health, Recreation, Open Space, and Trails Master Plan update, and our consultant will provide us with an overview of the draft plan and the recommendations.

Tuesday night's regular City Council meeting will also be held virtually. We will begin with considering six items on the consent agenda, and then will move to our public hearing items on the 2021 Budget. Staff will begin with providing an overview of the budget, and then we will move on to presentations on the Public Works Department, Enterprise Funds, and other funds. Our meeting will conclude with deciding if the November and December workshops should be canceled, and an Executive Session regarding personnel issues.

Coronavirus Update

Below are a few updates, but I would strongly encourage all to continue to follow www.fruita.org/covid19 for all updates we are posting. This also links to important Mesa County Public Health sources, as well as many others.

- **Updated Mesa County Public Health Order.** It is expected today that the Mesa County Board of Public Health will approve a new Public Health Order ('PHO") for Mesa County's Safer at Home Level Orange. Although the County is in the same level of the state's reopening plan, there are changes being implemented due to the increased number of cases. The release on the changes can be found here, and highlights include:
- o **Events and Gatherings** Indoor events, outdoor events, and public gatherings are not allowed under the new PHO.
- o **Bars and Restaurant** Bars that do not serve food must be closed (unless they are a variance protection program facility). Restaurants and bars that serve food are limited to 25% of the facility's normal capacity, not to exceed 50 people per room. Live music can also not be offered.

Honor the Past – Envision the Future $\begin{cases} FRUITA \end{cases}$

- Retail and Offices Non-critical retail sales establishments and offices are limited to 25% of the facility's normal capacity.
- Places of Worship Limited to 25% of facility's normal capacity, not to exceed 50 people per room.
- Recreation Facilities Limited to 25% of normal capacity, not to exceed 25 people per room.
- o **Private Gatherings** Limited to 10 people from no more than 2 households.
- Some facilities may fall into an exception to these requirements if they are enrolled in the Variance Protection Program.
- Fruita Civic Center & City Shops to Close. Beginning next Monday, November 16, 2020, the Fruita Civic Center and City Shops Facility will be closed to the public as a precautionary measure due to the spread of the coronavirus in the valley. Although the Civic Center and City Shops facility will be closing, almost all City business can be conducted online and remotely, and City services will continue with limited changes. Links to how to conduct City business online (such as pay a utility bill, apply for a planning clearance, and more) can be found at this link. We are also rotating more employees to work remotely to keep staff separate in effort to keep healthy and avoid mass quarantines that could hamper operations, which we have been fortunate to avoid thus far.
- **Outdoor Dining Spaces.** A yurt is being constructed at the Mulberry location to assist with inclement weather and maintaining outdoor, safe, social distanced public dining space.
- Free COVID-19 Community Testing Expands. Beginning on Monday, additional testing will be available to Mesa County residents. The additional community testing will be done in partnership with Colorado Mesa University and COVIDCheck Colorado. This testing site will be at Colorado Mesa University, and will be open Monday Friday from 3:00 p.m. to 5:00 p.m. Preregistration is required, and registration information can be found here. Residents can now get tested at Colorado Mesa University and at the Mesa County Fairgrounds. More information here.
- School District #51 Update. On Thursday, School District #51 announced that all high schools (including Fruita 8/9) will be transitioning to remote learning starting next Monday, and until after Thanksgiving break. Decisions on middle schools will be made today, and elementary schools will remain in person. Additional information can be found at this <u>link</u>.
- Colorado Mesa University Update. Beginning next week, Colorado Mesa University ('CMU") will also be transitioning to online-only learning before Thanksgiving break. CMU is also encouraging all students to get a COVID-19 test before traveling home. The full update from CMU President Foster can be found here.

Rise Above and FYAC Mural at Dinosaur Journey

This week, members of Rise Above Colorado and the Fruita Youth Action Council worked on a two-story mural at Dinosaur Journey. This mural culminates a year of planning and will be featured outside the front entrance of the Museum and is expected to be completed this afternoon. Rise Above Colorado is a statewide drug prevention organization providing Colorado's teens with information, resources, and healthy lifestyle alternatives to help youth choose a life free of drug misuse. Great work!





General Updates

- *Financial Update.* In September, City sales tax were up 24% when compared to the previous year, bringing our year-to-date total to a 26% increase. Use taxes on motor vehicles (48% increase) and building materials (496% increase), and County sales taxes (5% increase) were also up from the previous year. Finally, for the first time since February, the City's lodging tax was up 30% in September.
- **New Phone System.** Our new phone system is in the process of being installed to allow for better remote options.
- Pending Work. Spent much of this week updating our COVID-19 Operations Plan, leave policy, coordinated efforts and messaging with the Mesa County Economic Development First Responders, continuing our efforts to identify future options of fiber in Fruita, coordination with the Fruit Business Park, open enrollment for employees, etc.
- *Online Variety Show.* The Cavalcade's online variety show is tomorrow night! More information can be found here.

Parks and Recreation

- The Draft PHROST Master Plan will be reviewed and discussed early next week by the Steering Committee, Project Team, Staff, as well as representatives from our health, youth and school communities. Staff feels the plan is making good progress but still needs some work in the details. This is an opportunity to get further input from key stakeholders on that detail.
- Parks staff have been busy decorating downtown and the Fruita Community Center for the Holidays. As normal, the lights are anticipated to be turned on Thanksgiving eve.
- With the 5 Star rating, the FCC continues to operate under the new Health Orders but with some minor, self-imposed changes. Staff will be monitoring usage in the areas throughout the FCC and allowing only 50 patrons in the natatorium and 25 patrons in the fitness areas. We are also

- not going to reserve rooms at the FCC or the Civic Center for the time being. We recognize the increased pandemic numbers locally and are trying to implement social distancing operating procedures that reduce the risk of spreading the infection at the FCC.
- The FCC is slowly pulling its way out of the pandemic and in October reached 50% of revenues compared to 2019. And attendance at the FCC has been hovering in the low 40% range for the last three months, again compared to 2019. We hope this trend continues but also know the realities of what is happening with the surge in infections in our area. Staff continues to monitor and adapt where necessary. See Charts below.




