

#### **Coronavirus Update**

• First Doses of COVID-19 Vaccine Arrive in Mesa County. Update from Mesa County: "Mesa County Public Health (MCPH) has received the first shipment of the Pfizer COVID-19 vaccine to be administered to frontline healthcare workers in Mesa County. The distribution will be done in collaboration with the Colorado Department of Public Health and Environment (CDPHE) and local health care providers. #### Employee of the Year Award – Congratulations Tom Casal!

Congratulations to Tom Casal, Recreation Superintendent, for being named the 2020 Fruita Employee of the Year! Each year, employees nominate coworkers who have performed above and beyond and exemplified the City's core values. This year seven well-deserved employees were nominated. The Employee Engagement Committee then votes on the nominations, resulting in an employee of the year. Mr. Casal oversees the Fruita Community Center ("FCC") and all recreation programming throughout the City. Mr. Casal was nominated for the award for several reasons, including his leadership at the FCC throughout the pandemic, due to creating unique and safe events for the community, events such as drive-thru versions of the Easter Egg Scramble, Trunk N Treat, and Cookies N Clause, and for his

creative and innovative decision making that will allow the FCC to break even this year (after facing an almost \$700,000 deficit) even after an almost two-month closure. We appreciate all of Mr. Casal's hard work and leadership this year and are excited to name him Employee of the Year. - Economic Outlook Presentation. Staff and I attended the Grand Junction Chamber of Commerce's Economic Outlook event on Monday, which featured a presentation from Dr. Woobekind from the University of Colorado's Leeds Business School. Dr. Woobekind presented economic information and forecasts at the national level, as well as at the state and local levels. #### **Engineering**

- The Colorado Department of Transportation and Contractor KSK, LLC, will begin work in early January on existing curb ramps on CDOT's facilities to bring them into compliance. Work will begin in early January and will likely be completed by the end of January.

- Mesa County has contracted with MA Concrete Construction to reconstruct the Fremont St. (18½ Road) crossing of Little Salt Wash (south of L Road). This will result in a road closure of Fremont St. south of L Road and north of K.4 Road. This work is scheduled to begin around January 4, 2021 and last for several months.

• Clarke and Company was awarded the 2020 Fruita Roundabouts project in the amount of \$208,226. The project will begin later in winter with a spring completion.

- Thank you to all the families and friends who brought their kids to the annual Cookies and Claus event at the Fruita Community Center. Of course, it looked slightly different this year as Santa and his Elves were outside the FCC front doors handing out cookies and taking letters to Santa as kids drove through in their family's car.   environment at the Fruita Community Center. Drop in use is currently welcome but please note
  with the Holiday Break and the New Year, attendance may increase, and additional guidelines
  may be put in place.
