Tuesday's City Council Meeting

We have a full agenda with a total of 3 quasi-judicial hearings and 5 legislative hearings following the consent agenda. The big topic is the updates to the Land Use Code for Second Reading. Wednesday's City Council Workshop

City Council rescheduled the March 23 Council workshop to March 17 at 6:30 pm. This will be a virtual workshop with our consultant who is preparing the 2021 *Community Survey* in attendance to discuss ideas City Council has for topics to include in the survey. The packet will be sent out on Monday, March 15.

Coronavirus Update

- **Congress Approves and President Biden signs \$1.9 million "American Rescue Plan Act of 2021."** To view the bill, you may click [here](#). While the Sentinel reported today (Thursday) that Fruita stands to receive \$2.9 million in funding, I attended an update with the Colorado Municipal League Thursday and learned the amounts and restrictions of use are currently being determined and finalized and estimates will be released likely next week.

- **Vaccine Update from MCPH.** For emerging issues and updates related to the vaccine, you can find formation [here](#). This week’s update is:

None of the vaccines is recommended over the other, and all three are safe and highly effective at preventing COVID-19-related severe infections and deaths. We encourage you to get whichever vaccine type or product is offered to you when you become eligible for vaccination, as getting vaccinated greatly reduces the risk of illness if you are exposed to the virus. These are some of the main differences between the three vaccines currently available:

	Type:	Dose:	Ages:
Pfizer-BioNTech	mRNA	Two, 21 days apart	16 and older
Moderna	mRNA	Two, 28 days apart	18 and older
Johnson & Johnson	Viral vector	One	18 and older

People are considered fully vaccinated two weeks after their second dose in a two-dose series, or at least two weeks after a single-dose vaccine. If it has been less than two weeks since your shot, or if you still need to get your second dose, you are not yet fully protected. All vaccines require refrigeration and some require cold or ultra-cold storage that many facilities don’t have. Each vaccine’s storage temperature only matters for storage and transportation—it does not have an impact on the vaccine’s effectiveness. The Johnson & Johnson vaccine can be stored in a regular refrigerator, so a doctor’s office or a community location like a church or recreation center could potentially be a vaccination site, which would increase vaccine access. Many locations across Mesa County are offering vaccines, with more providers to be announced in subsequent distribution phases. Fruita Circulation Plan – New Interactive Map Launched! (continued)

In addition to the public survey that was recently launched for the Fruita Circulation plan, the Planning Team has also uploaded an interactive web map to provide feedback. General Updates

- **State of the City Video.** We have received three quotes from local groups for the “State of the City” video and will select one next week to begin working on it.

- **Citizen Survey.** A nearly final draft will be added to the Council Workshop packet Monday for the meeting on the 17th for Council to share thoughts and provide feedback to staff and our consultant.

Engineering

- **Current Ash St. Project.** Irrigation and sewer improvements are complete pending some City testing. Concrete, sidewalk and curb and gutter are being installed. Pavement will not occur until asphalt plants open, likely in mid-April.
- **Maple St. Project.** Underground work begins this coming Monday. The intersection at Maple and Aspen will be closed until contractors are out of that intersection, hopefully within a two-week window. Asphalt milling (in preparation for underground work) is complete as of this afternoon.
- **Highway 340 Roundabout Project.** Construction and landscaping are progressing well on the roundabouts. Jeff Bates is working hard on the sculptures.

Human Resources

- The St. Mary's Bloodmobile will be in the Civic Center Parking lot and will be accepting blood donations on Tuesday, March 23, 2021 from 1:30 to 3:30 p.m. This is by appointment only and masks are required. To make your appointment please click [here](#).

Finance/City Clerk

- **City sales tax** revenues continue to be robust with an 8% increase for January compared to the prior year. On the upside, retail trade is up 20% from January 2020 and on the downside, oil and gas activity is down 92% from the prior year.
- **The monthly financial report** that will be in the March 16 packet includes some new information. Annual information on various utility billing statistics for 2017 through 2020 is attached as well as an aging report for utility billing receivables for February.
- **Municipal Election 2022.** Over the next several months we will be looking into alternatives for tabulation and signature verifications for the City's 2022 election as Mesa County will not be able to assist in the election process. We will also reach out to other municipalities in the County to see if there are some collaborative solutions which will be of benefit to us all.
- **Municipal Code and Meeting Management.** We are in the process of entering into an agreement with MuniCode for codification services for the Fruita Municipal Code and Agenda and Meeting Management software to streamline our processes and hope to have these solutions up and running in the next several months.

Parks and Recreation

- **The Fruita Youth Action Council** is accepting applications for the 2021/2022 School Year. Potential candidates need to be in 6th through 12th grade in the 2021/2022 school year. For information or to apply, they can go to www.fruita.org/FYAC.

- **New Special Event Application.** The new online Special Event Application is now live on our website as well as a new *Special Event Guidebook* that should hopefully help event coordinators to plan events here in Fruita. The webform and guide can be found [here](#).
- **Lap Swim at FCC.** Starting March 22, the Fruita Community Center will no longer use Signup Genius for lap swim reservations. Lap swim rules will revert back to pre-pandemic rules of first come, first serve.

Police Department

- The Police Department is working with Councilor Leonhart and some dedicated community members to explore options and strategies regarding feral cat populations in Fruita. Some of the initial prospects include partnering with local veterinarians and non-profit groups regarding trap/neuter/return strategies. More information to come as the details get fleshed out.

Public Works

- Completed a required Inflow & Infiltration report for the Wastewater Reclamation Facility.
- Continue to cross-train staff on critical functions in various divisions.
- CMU purchased and picked up 32 yards of biosolids this week.
- The Fruita billboard lights have been installed and we are waiting on an advertisement cover to assess the lights.
- Crack sealing City streets continues — streets that have been completed include Vermont Lane, Vermont Court, Middlebury Court, Ute Canyon Court, Wingate Drive and Red Canyon Avenue. Streets scheduled for crack sealing include Echo Canyon Street, Bonsai Avenue and Hickory Street.
- Crews will start cleaning and burning ditches in the right-of-way next week.
- City irrigation is set to be turned on April 5 & 6.


