## **Coronavirus Update**

Below are a few updates, but I would strongly encourage all to continue to follow <u>www.fruita.org/covid19</u> for all updates we are posting. This also links to important Mesa County Public Health sources, as well as many others.

• **Vaccine Update from MCPH.** Yesterday, Mesa County Public Health released an update on COVID-19 vaccinations. The full update can be found <u>here</u>, but here a few highlights from the update:

• Mesa County entered Phase 2 (the general public) of vaccine distribution on April 2. Eligible populations include all individuals 16 years and older as well as previously qualifying individuals.

• Appointments are required for COVID-19 vaccination, you can visit their website for scheduling, links are available in <u>English</u> and <u>Spanish</u> for an appointment as soon as the next day.

• Mesa County Public Health is administering about 1,000 vaccines per day, and as of last week, 64,288 doses have been given.

• Volunteers are needed! If you would like to volunteer at the vaccine clinic, you can sign up <u>here</u>.

• **American Recovery Plan & Other Funding Opportunities.** As the City is set to receive ARP funding, we are still awaiting the specific US Treasury language on eligible expenses. We are attending many trainings and updates on many pending funding opportunities in addition to ARP. It is critical that we learn about all opportunities and strategically plan to leverage each opportunity to maximize achieving community priorities and needs.

• **State Resiliency & Recovery Roadmap Process.** You may recall the City took the lead for all of Mesa County to submit a letter of interest for this program. The state did receive funding and 16 letters of interest from regions. I attended an update this week and formal applications are now open and due May 13. I have briefed the Mesa county First Responders (all cities, county, GJEP, Business Incubator Center, Workforce Center, CMU, all Chambers of Commerce, etc.) and we are considering full application over the next two weeks, which entails a two-year process working with a state funded consultant to create a recovery roadmap plan and begin implementation. There is no financial commitment.

## **General Updates**

- **Spring City Link.** The Spring City Link is complete and should be arriving at homes late next week. If interested in reading beforehand, you can visit this <u>link</u>. This edition has articles on the Community Survey, the Land Use Code changes (and where to find more information), an employee spotlight, and more.
- **Outdoor Public Dining Spaces.** On Thursday, crews began work on removing the Peach Street Dining spaces and opened Peach Street for parking and traffic this morning. Tables and chairs have been relocated to the stage at Civic Center Park and the Mulberry St. public dining space. The Mulberry Street closure will remain in place and opening Peach Street will help north/south travel in the downtown area as well as provide easy access to public parking at the Civic Center. The yurt has been converted to an open-air shade structure with seating inside. Public Works has identified a way to change the temporary road closure signs in a more presentable fashion, while still meeting required traffic control liability standards. This is on order and will be placed as soon as we receive. Originally, these spaces were designed to be temporary, tied to COVID-19 capacity related requirements. Now that restrictions are loosening, yet demand is high for seating, after talking with just over 20 of the downtown businesses, opening Peach and maintaining Mulberry was a clear consensus.
- Waste Management Report. In March 2021, Fruita residents recycled 58 tons of cans, bottles, paper, and cardboard. Great job Fruita! If interested in learning more, the full report is provided below.
- **Partner Meetings.** This week I was able to catch-up with various partners, Family Health West, Charter Communications, Fruita Area Chamber of Commerce, ED First responders, Neo Connect (who completed the County's Broadband study), Colorado Municipal League Legislative Committee, Senators Bennet and Hickenlooper, many downtown businesses, Bray, Lower Valley Fire District and thanks to staff, the Fruita Trail Initiative, and other cities regarding the CO Main St. Program.
- *City Sales Tax Update.* After 4 straight record-setting years of City sales tax revenue growth, 2021 is off to a great start 13.38% over 2020 for Jan-Feb, February coming in 19.97% over Feb. Of 2020.
- *City Lodgers Tax Update.* City lodging tax has been relatively flat through January and February, but it is encouraging to see the revenues return to previous year averages (after significant decreases during the pandemic).
- Use Tax. Building materials is up 72.21% over Jan-Feb 2020. Motor Vehicles is down 6.02% compared to Jan-Feb

### Engineering

- Ash Street paving was placed this week for the trench patch. Once the 2021 overlay project is out for construction, the street will receive an overlay for the entire width.
- Work should pick back up on Maple St. Sewer project next week.

- Concrete trail connection in Orchard Ridge and Evening Breeze subdivisions will receive bids on Friday April 16.
- 30% plans for Fremont St. design was received by staff last week and reviewed and submitted to CDOT for review. The field inspection review meeting with CDOT will be held later in April.
- A kickoff meeting with GA Western Construction Co. and SGM Engineering was held on Friday for the Pine Street Bridge project.

## **Parks and Recreation**

- Staff continues work on updates to COVID requirements for the Community Center for upcoming reopening phases.
- Excited to see the first of three sculptures in each roundabout installed!
- Parks crews assisted in the relocation of seating in the downtown area.
- Appreciate City Council's adoption of the Parks, Health, Recreation, Open Space & Trails (PHROST) Master Plan Tuesday night!

### Public Works

Irrigation water is scheduled to be turned on April 12<sup>th</sup>. All siphons, low point drains, head gates, trash cleaners, and culverts are ready to go. If you are located in a Homeowners Association (HOA) please check with them if you are having irrigation issues. - Seasonal workforce is coming on board with two seasonal employees hired in Streets and one in Collections.
- Staff is researching alternatives for the road closure signs at the Mulberry Street outdoor dining space that meets the MUTCD safety requirements but is more aesthetically pleasing.
- Fleet Services is ensuring summer equipment is ready for use, including mowers, street sweeper, and crack sealing equipment. New vehicles are beginning to arrive including a patrol unit and public works truck. Other units are expected to arrive in the next couple of weeks.
- Right of Way (ROW) maintenance has started and crews are completing crack sealing on Elmwood Heights subdivision, Evening Breeze Subdivision, Birchwood St., Juniper St., Bayberry Ct., Apple St., Sycamore St., and Wildwood Acres.
- Enoch Reservoir water was shut off on 4/6/2021.
- Ute Water is continuing to complete service line checks throughout the community. Staff has completed 234 locates for the month of March and has completed 18 locates so far for the month of April.
- Wastewater Collections is cleaning wet wells at all lift stations and is scheduling Maple St. Sewer inspections.
- With many funding resources becoming available at both the state and federal levels of government, staff attended the CDOT Revitalizing Main Streets Webinar regarding potential grant funding. This grant is for multi-modal projects that improve the safety and provide benefits to community main streets. Staff will be discussing potential projects in the near future. This is the second round for the grant, and in the first, the City of Fruita was awarded a grant to improve wayfinding efforts on the Colorado Riverfront Trail and created four internal urban trails that are still being worked on.

Enough airspace to fulfill the annual municipal waste disposal needs for 159 people!

#### 119,055 Kw-Hrs of Electricity

Enough power to fulfill the annual electricity needs of 11 homes!

#### Avoided 160 Metric Tons (MTCO2E) of GHG Emissions

The recycling of these materials prevented these GHG emissions!

#### 284,921 Gallons of Water

Represents enough saved water to meet the daily fresh water needs of 3,798 people!
