#### **Coronavirus Update**

Weekly Vaccination Update. Here are a few highlights from latest vaccine update from Mesa County Public Health. The full report can be found at his link.
The Power the Comeback COVID-19 Vaccine Bus is making stops at the following locations:

- **Country Jam** (inside the gates on the promotional row) Thursday, June 24 through Saturday, June 26 from 2 p.m. to 8 p.m.
- St. Joseph's Catholic Church (White Ave. between 3rd and 4th Streets) Sunday, June 27, 9 a.m. to 1 p.m. \*Bilingual staff on bus
- St. Mary's Hospital (2635 N. 7th St.) Tuesday, June 29, 8 a.m. to 4 p.m.
- Community Hospital (2351 G. Rd.) Wednesday, June 30, 8 a.m. to 4 p.m.
  - No appointment, ID, or insurance is required for any mobile vaccination clinic listed above. All vaccines are free of charge.

 $\circ$   $\,$  As of the week ending June 19, 52,919 first doses and 53,850-second doses have been administered in Mesa County for a total of 106,769 doses.

• Approximately 40% of Mesa County residents aged 12 and older are fully vaccinated, meaning they have received both doses in a two-dose series, or a single dose vaccine.

• A <u>Vaccine Dashboard</u> is updated weekly on the MCPH website with new data related to vaccine by age group.

• Unvaccinated Large Gathering Attendees Urged to take Precautions as Variant Spreads Rapidly. One more update from MCPH – the Health Department is encouraging those attending Country Jam or other large-scale events to get vaccinated to protect themselves from COVID-19 and variant strains. From MCPH: "The Delta Variant is spreading rapidly in Mesa County, and not does it spread faster, it carries nearly double the of hospitalization". The full report can be found here.

#### Wild Cow Fire Update

The Wild Cow Fire was reported on June 21, 2021 and is located near Baxter Pass in Garfield County north of the Grand Valley. The fire is currently 553 acres, and there are 54 personnel currently working on the fire. The Emergency Management Command Center is now at the Fruita 8/9, and that is why you might be seeing a lot of fire traffic in and out of Fruita. Updated information on the fire can be found <u>here</u>. CDOT has also recently shared that Hwy 139 will likely remain closed tonight due to the Oil Springs Fire.

#### Valley-Wide Water Quality

The Colorado Department of Public Health and Environment (CDPHE) has developed a Total Maximum Daily Load (TMDLs) Assessment for the Colorado River tributaries in the Grand Valley. The assessment was sent out as a draft for review in April of 2021 with a deadline to respond in June. The scope of the TMDLs presented in the document addresses selenium, iron and *Escherichia coli (E. coli)* impairments found in certain tributaries within the Grand Valley, located along the Colorado River. The tributaries represent a combined drainage area of approximately 138 square miles. Reductions in Selenium, iron, and E. coli are identified for Adobe Creek, Little Salt Wash, and Big Salt Wash in the Fruita area.

Mesa County, Grand Junction, Fruita and Grand Valley Water Users Association teamed up to provided comments to the draft assessment in late April. Members of staff of each of the jurisdictions met with the CDPHE on Thursday June 24<sup>th</sup> to discuss the comments and concerns of the collective group. CDPHE staff stated that they will be responding to all comments received by the end of July.

#### Stage 1 Fire Restrictions in Place – Mesa County (Continued)

The Mesa County Sheriff, the Bureau of Land Management, and Fire Chiefs representing municipalities and fire protection districts of Mesa County are implemented Stage 1 Fire Restrictions last week. Stage 1 Fire Restrictions prohibits the personal use of fireworks, campfires outside of designated fire puts or fire rings, agricultural opening burning without a Sheriff's issued burn permit, use of explosive targets, and smoking outside near combustible materials. #### **General Updates**

- *City Council Ice Cream Social.* Next week's Thursday Night Concert event is the Annual Ice Cream Social, presented by Fruita City Council. The Centennial Band will be playing and please note that the concert starts at 7pm. As always, the concert and ice cream is free for those that attend.
- **Country Jam.** Country Jam is back this week! If you are heading out there, we hope that you have a fun and safe weekend. Also, if you are going, the Mesa County Sheriff's Office has asked that attendees use I-70 as the primary route to get to Mack, and to keep Hwy 6&50 cleared between Fruita and Mack for fire crews battling the fire near Baxter Pass.

#### Engineering

- *Mesa County Chip Seal Project.* Traffic update: June 28 to July 2. The Mesa County chip seal project will take place at the following four locations: US Highway 6 from Mile Point 11 to MP 20, CO Highway 139 from MP 0 to MP 6, US 50 Frontage Road from MP 33.8 to MP 36.2 and CO 141 from MP 120 to MP 154. For the week of June 28 to July 2 motorists should plan for: CO 141 from MP 120 to MP 154 Monday through Thursday. North and southbound one-lane alternating traffic with pilot car operations and minimal delays with a 12 ft. For more information, you can visit this <u>link</u>.
- **Concrete Thermal Heaving.** There has been a number of concrete heaves throughout the city due to thermal expansion with the hot weather. Seven locations have been identified and half have been completed with repairs so far.
- *Maple St. Aspen Street Closures.* Paving is still on track to begin on July 14th.
- **19 Road Closure.** 19 Road will remain closed for at least another week. Optimistically, the road may open as early as July 2<sup>nd</sup>.

- **3**<sup>rd</sup> of July Fireworks Show. The City of Fruita Parks and Recreation Department is working with the Mesa County Sherriff's Office and the Lower Valley Fire District to determine if the 3<sup>rd</sup> of July Fireworks Show should proceed. At this time, Mesa County has Stage 1 Fire Restrictions in place. If Mesa County moves to Stage 2 Restrictions, it is possible that the event will be canceled. We will continue to provide updates here and on our website as more information becomes available.
- Irrigation Break at LSWP. There is a break in the main irrigation line just outside the pump house at Little Salt Wash. Staff has exposed the break and is in the process of making repairs. The system may not be back online until Monday. As a result, turf at LSWP won't be watered for up to 6 days. Luckily the cooler weather has helped the situation but we still may see some drying out of turf.

#### **Public Works**

- **Encanto Line.** Irrigation water on the Encanto line is currently unavailable following a pipe failure. Crews repaired the pipe this afternoon and water should be available to users tomorrow. The Encanto line serves a number of subdivisions in northeast Fruita, such as Canterbury Park, Windsor Park, Brandon Estates, Phyllis Drive, Vista Valley, and a portion of Pine Street.
- **Mountain Water Update.** GPPWUA has requested the City turn on Mountain Water. The City's plan is to flow water from Reservoir #1 and Reservoir #3 at the requested 330 Gpm over Windy Point which is about 1 ½ acre feet a day.

- **Moss Removal.** Grand Valley Irrigation System is working on moss removal in the Ranchman's ditch. PW staff continues to clean head gates and has installed headgate cleaners developed by staff to help keep the moss from building up on the headgates.
- **Asphalt Repairs.** Crews completed asphalt patches on Ruby Lee, Annabelle, Placer Drive, and Comstock.
- **WWRF Tour.** Wastewater Superintendent Terry Anderson provided a tour of the WWRF facility and processes to Councilmember Heather O'Brian.

## Stage 1 Fire Restrictions Fact Sheet





Agricultural burns with SHERIFF'S OFFICE ISSUED PERMIT ONLY! Mesa County Fire Marshal will do a safety inspection prior to issuing permit.

Only PERMITTED PROFESSIONAL FIREWORKS displays are allowed.







The personal use of all fireworks are prohibited during fire restrictions.





Any fire or campfire, not within a permanently constructed fire grate in a developed park, campground, private residence, or picnic area.



Smoking, EXCEPT within an enclosed vehicle or building, a developed recreation site, or while stopped in an area of at least six feet diameter that is barren or cleared of all combustible material.

Operating or using any internal combustion engine, such as chainsaws, without a spark-arresting device properly installed, maintained, and in effective working order.



Welding or operating acetylene or other torch with open flame EXCEPT in cleared areas of at least 10 ft in diameter and in possession of a chemical pressurized fire extinguisher.

Target shooting with explosive targets is not permitted.
