On the administrative agenda, we will continue our 2023 Budget presentations and staff will cover Quality of Place and Community Wellness highlights from the budget and discuss personnel changes. We will then wrap up with reports.

#### Weekly FAQ

In every weekly update, we will be answering one question we get asked often from the community. These questions will cover a variety of topics from all city departments. - Question: Can I pile leaves/yard waste into the street?
- Answer: No, the City of Fruita does not have the required equipment to pick up large piles of yard waste in the street. City crews do have a street sweeper which cleans the streets from debris but cannot pick up large piles. The City of Fruita asks residents to properly dispose of yard waste to help maintain the City's stormwater system. The best way to dispose of yard waste is to bag it and place it in your trash container on your regular trash pickup day. Yard waste includes leaves, grass clippings, tree limbs, brush, soils, rocks, or debris that results from landscaping, gardening, yard maintenance or land clearing operations.

#### **General Updates**

- *Fruita Strategic Plan.* The City of Fruita's Strategic Plan is now available online at Fruita.org. The plan outlines City Council's priorities over the next 2-4 years in addition to the City's core service delivery. The plan aligns with the City's other planning documents like the comprehensive plan, community survey, and other master plans. Overall, it was a quiet night.
- Working Along Side Public Works. Friday, Director Kimberly Bullen and I worked with our streets crew on patching asphalt on Drumlin Circle. The crew showed us step-by-step how they work together to patch the road. We had a blast learning from this fun and efficient team!



- **Working with GJEP.** Grand Junction Economic Development Partnership staff and I met with a prospective manufacturer interested in relocating to Fruita. It was a great meeting and hopefully has positive results in the future.
- Home Builders Association of Mesa County Engagement. Planning & Development Director Dan Caris presented to the HBA at our request to cover the transition of bringing Building Services inhouse rather than continuing to contract with Mesa County to provide those services.
- *Western Colorado Contractors Association.* City Engineer Sam Atkins presented to the WCAA along with other jurisdictions in the valley on capital projects anticipated in 2023.
- **Vets Ride Free in November.** Grand Valley Transit will be offering free fares to veterans during the month of November. #### Engineering

- **Pine Street Bridge.** Both high and low-pressure gas have been temporarily relocated as well as overhead power in anticipation of the demolition of the existing bridge. The communication lines are anticipated to be moved next week.
- Little Salt Wash Trail. The Little Salt Wash Trail near Creekside Subdivision will be closed for a few days next week for concrete repairs. The trail will re-open for use towards the end of the week.
- **N. Mulberry Streetscape Improvements.** Bid documents will be available Monday for the North Mulberry Street Outdoor Space project. They will be available online at <u>our website</u> as well as Bidnet and the Western Colorado Contractors Association.

#### **Police Department**

• **Calls for Service Statistics.** Statistics from the Grand Junction Regional Communications Center show calls for service for Fruita PD at 781 for the month of September, 2022. In the month of September, 2021, we responded to 843 calls for service. Year to date in September we had responded to a total of 4,857 calls as opposed to 5,117 year to date in 2021, showing a 5% decrease.

#### **Public Works**

• **Building Maintenance Update.** Sheetrock was repaired and installed in the Civic Center basement.

- *Fleet Maintenance Update.* Snow removal equipment is being installed on multiple pickups and dump trucks.
- **Road Maintenance Update.** After Truck-N-Treat, traffic control was picked up and downtown was swept. N. Peach St. was crack sealed.
- **Utilities Update.** Mountain Water winterization is complete. Lift station heaters were checked and generators inspected. Multiple storm drain inlets and vaults were cleaned. 33 utility locates were completed.
- **Wastewater Treatment Update.** The discharge limitations have been reduced by roughly 50%. Below are the new concentrations that the Wastewater Reclamation Facility will be required to meet.
  - Hg (Mercury) 0.01 from 7.3ug/l
  - Hexavalent Chromium (6+) 11 from 23.7ug/l
  - Ag (silver)partially dissolved .59 from 10 ug/l
  - Nonylphenol 6.6 from 10 ug/l
  - CN (Cyanide) 5.0 from 57 ug/l
- *Admin Update.* Staff participated in an American Public Works Association webinar on calibrating winter operations equipment.
