Tuesday's City Council Workshop and Meeting

As a reminder, we have a special workshop scheduled prior to our regular meeting next Tuesday, and the purpose of the workshop is to receive a final report and presentation from our contracted consultant on the POST (Parks, Open Space and Trails) Impact Fee Study. The workshop is scheduled for 6:00 p.m.

After our workshop, our regular meeting will begin with swearing in the newest member of the Fruita City Council, Aaron Hancey. The Council will then move on to three items for proclamations and presentations, the first being a presentation to former City Councilor Heather O'Brien, then a proclamation to honor Jeff Bates, and a proclamation for "Lights on After school Day." After that, the Council will consider several items on the consent agenda, and there are seven public hearings on the agenda. For Administrative items, staff will present an overview of the Infrastructure and Core Services projects included in the 2023 Budget. We will conclude the meeting with a discussion on council liaison positions on Boards and Commissions. See you on Tuesday night! View the agenda and packet online.

Leaf Pick Up for Waste Management Pilot Areas

To help residents in the Waste Management pilot program dispose of fallen leaves, during the week of November 7, 2022, residents can place extra bags of **leaves** next to their trash can for pick up. Waste Management will pick up extra bags of leaves on your normal pick-up day (depending on volume, they may have to finish the following day).

- Leaves must be bagged.
- Bags must be 3 feet away from your trash cart.
- Only bags of leaves will be picked up.

In August 2022, residents in the pilot program received a 96-gallon cart. If you are unsure if you are a part of the Waste Management pilot program, please review the pilot program maps.

Truck-N-Treat & Trick-or-Treat Street

Head to downtown Fruita on Saturday, October 22, from 10 a.m. - 12 p.m. to enjoy Fruita's Halloween events! In the street Around the Civic Center, the City's Truck-N-Treat event will be taking place with large trucks dressed up for Halloween. Walk around each truck to explore and collect candy from vendors. On Aspen Avenue, enjoy the Fruita Area Chamber of Commerce's Trick-or-Treat Street event where local businesses will be handing out candy. During these events, Aspen Avenue from Circle Park to



Maple Street and Peach and Elm Street will be closed. This is our first year combining the events now that the Trick-or-Treat Street event has grown large enough to require closed streets.

Weekly FAQ

In every weekly update, we will be answering one question we get asked often from the community. These questions will cover a variety of topics from all city departments. If you have any questions, you think would be valuable for us to share, let us know by emailing communications@fruita.org.

- Question: Do I need a business license in the City of Fruita?
- Answer: Yes, if you are doing business in the City of Fruita you must have a business license. Receiving a business license is easy! You can find the <u>business license</u> <u>application</u> online or visit the Fruita Civic Center to pick one up. There is a \$25 annual fee for the license, and you will receive a renewal reminder in the mail at the end of each year.

General Updates

- Financial Reports. Sales tax numbers for August 2022 are now available and can be found in the Council packet for our meeting next Tuesday. Quick highlights of the financial reports, in August 2022, when compared to the previous year, City sales tax collections increased 24%, and is trending at an increase of 9% year-to-date. Use tax collections on building materials (up 79% in August, trending at an increase of 41% year-to-date) and county sales tax collections (up 19% in August, up 10% when compared to the previous) also saw increases from the prior year. On the other side, use tax on motor collections (down 25% in August 2022, trending at a decrease of 1%) and lodging tax collections (down 20% when compared to August 2021, trending an increase of 2% overall) were all down from the prior year.
- **Bike Ride with the City Manager.** We enjoyed a ride in the Fall weather on the Kokopelli section of the Riverfront Trail discussing the City's public-private partnership in the Fruita Business Park, with the Imondi Wakeboard Park, the City's wastewater reclamation facility and long-term planning and engagement efforts and results.
- Mobile Mesa County Newsletter. The October 2022 Mesa County Newsletter is now available
 and can be found <u>here</u>. It includes information on Grand Valley Bike Month, the Safe Routes to
 School Program, upcoming events, and more.
- *Mesa County First Responders.* We hosted a meeting with all cities, county, CMU, all chambers, GJEP, and the BIC to reset our regular meetings and plan for the wrap up of the Roadmaps Recovery process in the next month.
- 2023 Fruita Fat Tire Festival & GJ Rides & Vibes conflicting schedules. We met with the Greater Grand Junction Sports Commission to express our concerns with the scheduling of the 2023 Ride & Vibes Mountain biking racing event on the same weekend as Fruita Fat Tire Festival since it could split vendors and participants who typically participate in both. This will be 28 years since the Fruita Fat Tire Festival began and arguably played a major role in putting this area on the map for mountain biking. We are in full support of Rides & Vibes. We will work with the parties involved to coordinate as effectively as possible.

- **Pumpkin Dunk on Friday, October 21.** The Fruita Community Center's indoor pool will become a floating pumpkin patch from 4:00 p.m. 6:00 p.m. on October 21. There is a \$10 pre-registration required to reserve a pumpkin.
- Truck-N-Treat on Saturday, October 22. Our annual Truck-N-Treat will be held from 10:00 a.m. 12:00 p.m. on the streets surrounding the Civic Center. Trucks, equipment, vehicles, and more will be decorated for Halloween and ready to hand out candy to our community. Costumes are encouraged and truck horns will sound at noon!
- Alzheimer's Education Series Returns to the Fruita Community Center. The first of a two-part series about Alzheimer's will be held on October 19 at 1:00 p.m. Join us to learn about "Advancing the Science: The Latest in Alzheimer's and Dementia Research". This program will have light refreshments and snacks, please pre-register.
- Adult Co-Ed Volleyball is Now Open for Registration. Our fall adult volleyball league will be held on Sundays from 10/23 11/27 in the afternoon and evening. There is a \$190 fee per team. Learn more and sign up at the Fruita Community Center!

Public Works

- **Building Maintenance.** The Police Department fire inspection and annual fire extinguisher inspection was completed.
- **Fleet Maintenance.** Brake work was performed on the Fleet service truck. Hydraulic work, a service, and an annual DOT inspection was performed on a Vactor truck. Shocks, steering rack, pinion assembly, hub assembly, and tires were replaced on a Parks vehicle.
- **Road Maintenance.** The crew crack sealed and painted parking stalls at the Fruita Community Center during their maintenance week. Signage was installed for a dead-end road.
- *Utilities.* 3,454 feet of sewer lines were cleaned. The IIG lift station is having minor electrical issues that is being troubleshooted. Staff assisted with setting up a pump for the Fruita Community Center pool maintenance project.
- Wastewater Treatment. The Wastewater Superintendent is working on cost reductions for the H2S Mitigation Project.
- Admin Update. Public Works staff continue to work with Construction Manager at Risk (CMAR) on the H2S Mitigation Project. Interviews for the Public Works Superintendent were held this week.
