## **Tuesday's City Council Workshop**

We have two items up for discussion at our workshop on Tuesday. The first agenda item is to provide the City Council with an overview of the Waterworth program that staff is using to make revenue projections and build scenarios based on operating and capital expenditures in the Sewer Fund. The second item is our October check in on the draft 2024 Budget. As part of this check in, we have three items: (1) general questions from the City Council, (2) review of outside agency funding requests, and (3) a review of the compensation of the City Councils throughout Western Colorado. #### Weekly FAQ

In every weekly update, we will be answering one question we get asked often from the community. These questions will cover a variety of topics from all city departments. - Question: I have a lot of leaves in my yard, can I blow them into the street?
- **Answer:** No, the City of Fruita kindly asks residents to please avoid placing leaves, rocks, and other debris in the streets. Our crews use a street sweeper to clean the roadways, but these machines cannot pick up large debris. The debris will then find its way into the sewer and storm drains, which can cause damage and/or potential contamination.

#### **General Updates**

- Drive Lead Succeed Annual Conference Tour. On Wednesday, as part of the conference, we
  hosted a lunch in the Mulberry Plaza for conference attendees. The group learned about Fruita's
  economic development from me and Community Development Director Dan Caris. I also led the
  full tour and answered questions about Fruita on the drive to and from Fruita. After lunch, the
  group enjoyed a tour from Over the Edge, the FARM, and Imondi Wakezone, and the Colorado
  National Monument. Much thanks to the Fruita Area Chamber of Commerce for planning the
  tour.
- *Trail Clean Up with Livability Commission.* Yesterday afternoon, staff joined the Livability Commission on their clean-up of a portion Colorado Riverfront Trail on the southside of Fruita. It was a beautiful afternoon, and the group were able to make quick work of the trail clean up. Thank you to Livability Commission for your volunteer work!
- Fruita Mews Property Management Contact. We continue to receive inquiries from interested parties regarding the Mews Development, currently under construction. In collaboration with the developer, IndiBuild, we have created a web page at <a href="www.fruita.org/fha">www.fruita.org/fha</a> for more information, which also includes contact information for those interested in living at the Mews.
- Update Draft Budget and Presentations. An updated version of the City Manager's Recommended 2024 Budget was uploaded to our website last week, and can be found at our website here: 2024 City of Fruita Budget Draft. In addition to the draft, staff will be uploading all of the presentations that have been shared with the City Council throughout the budget process. The first PowerPoint presentation, on Infrastructure and Core Services, that was shared this past Tuesday, can be found at the bottom of the page. #### Engineering

- Kismet Construction Update. CW Construction closed Mesa Street to through traffic again this
  week to complete paving of the asphalt patches. This completes the work for the water and
  sanitary sewer installations in the public Right of Way. Mesa Street should be open by Friday
  afternoon.
- **Reed Park Improvements.** The bid opening for Reed Park is scheduled for this afternoon at 1:30 p.m. We will review the bids and provide an update to the Council at a future meeting, after evaluating the bids and ensuring that all components of the project can be met.

#### **Parks and Recreation**

- **Pumpkin Dunk Tonight!** We're turning the FCC's indoor pool into a floating pumpkin patch! Families are invited to go dunkin' for pumpkins. Registration is required for this event and each person registered is guaranteed a pumpkin. The pool will be closed to open swim during this event.
- Winterization has begun. Parks crews have started winterizing irrigation systems at our parks. They will be blowing out all systems over the next month.

- Water fountains at Fruita Bark Park, Fruita Bike Park & Circle Park. Both fountains are not frost-free units and need to be winterized annually. This winterization has now occurred, and they are shut off for the winter.
- Holiday decorating begins next week. Parks crews will start decorating the downtown corridor
  and city facilities with holiday lights next week. They will complete all decorating by November
  22<sup>nd</sup> with the lights being turned on during the Downtown Lighting and Small Business Saturday
  event on November 25<sup>th</sup>.
- FCC Staff attended Community Hospital Benefits Fair. Tina Ross and Hannah Bihr attended the benefits fair and talked about our Fruita Parks and Recreation with employees. There were around 125 employees who visited the table inquiring about our programs and community center.
- Goal Academy using the Fruita Community Center for school. GOAL Academy is using our facility to host their online school for local Fruita students. Proximity here is convenient for both staff and students versus driving into Grand Junction. The partnership could evolve into a more permanent situation, ie:1-5 year lease. We will reevaluate it at the end of this year.

#### **Public Works**

- State Revolving Loan Funds. The Public Works Director and Superintendent attended a Pre-Qualification meeting with the State of Colorado Department of Public Health and Environment, Department of Local Affairs, and Colorado Water and Power Authority to discuss potential funding through the State Revolving Loan Fund (SRF) program for sewer line replacements. This is the first initial step in the SRF process.
- **NRCS Update.** The City was informed by the NRCS that our Mountain Water property project is not going to be recommended for funding through the PL-566 program.
- Roadway Assessments. Public Works staff reviewed the Roadway Assessment Service (RAS)
  data Boss software that develops a number of scenarios for roadway treatments, overall
  improvement to the roadway system and PCI scoring and cost estimates based on type of
  treatment.
- **Streets Update**. Streets crew completed a large asphalt patch behind Kim's Auto and two additional patches on Marigold. Crews will begin working on a temporary parking lot at 169 S. Mulberry and will begin crack sealing streets.
- Utilities Update. The Utilities crew completed 80 utility locates this week and shut down the
  irrigation system for the season which included flushing the system prior to headgates being
  closed.
- Mountain Water. Staff completed winterization of Mountain Water properties.
