DEDICATION

KNOW ALL MEN BY THESE PRESENTS.

That the undersigned, William A Roberson aka W.A. Roberson, Grace Roberson, Joe Willoughby, Jerry B Evans, Nancy L. Evans, George D. Pickens, Patricia Lee Pickens and Larry W Paulson are the owners of that real property situated in the town of Fruita, County of Mesa, State of Colorado, and lying in SW 1/4 SW 1/4 of Section 8, as shown by the accompanying plat thereof: said tract being more specifically described by metes and bounds as follows:


Beginning at a point which is 635.0 feet South and 40.0 feet West of the NE corner SW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 8, TIN, R2W, of the Ute Meridian, thence West 180.0 feet, thence North 325.0 feet, thence West 68.0 feet, thence North 120.0 feet to the South line of Alfalfa Ave, thence West 202.0 feet, thence South 568.68 feet to the center line of Roberson Ave., thence along the arc of a 255.0 foot radius curve to the right 76.23 feet, the chord of which bears S.81°26'W.75.97 feet, thence West 94.9 feet, thence South 1500 feet, thence S.89°50'E 2354 feet, thence N54° II'E 283 II feet, thence East 155 O feet, thence North 120.0 feet to the point of beginning.

That the said owners have caused the said real property to be laid out and surveyed as Replat of Lots 5, 7 to 17 & 21 to 29 of ROBERSON ADDITION, a subdivision of a part of the County of Mesa,

That said owners do hereby dedicate and set apart all of the streets and roads as shown on the accompanying plat to the use of the public forever and hereby dedicate those portions of said real property which are labeled as utility easements on the accompanying plat as easements for the installation and maintenance of such utilities as telephone and electric lines, poles and cables, storm and sanitary sewer mains, water mains, gas pipe lines; and those portions of said real property which are labeled as irrigation easements on the accompanying plat as easements for the installation and maintenance of irrigation ditches, flumes and conduits;

That all expenses for installation of utilities or ditches referred to above, for grading or landscaping, and for street graveling or improvements shall be financed by the seller or purchaser --- not the Town of Fruita.
