
STANDARD TERMS AND CONDITIONS OF PROBATION

- _____ 1. The Defendant shall not commit any criminal offense against the United States of America, the State of Colorado, City of Fruita, or any other jurisdiction and the Defendant shall report immediately to the Fruita Municipal Court, in writing, any arrests or complaints filed against him or her.
- _____ 2. The Defendant shall work faithfully at, or diligently seek, suitable employment or reasonably pursue a course of study or vocational training that will equip him or her for suitable employment.
- _____ 3. The Defendant shall complete any counseling, educational, medical or psychiatric treatment if so ordered by the Court and promptly file verification of attendance and/or completion as ordered by the court.
- _____ 4. The Defendant shall submit to substance testing at the direction of the court, and it will be at your expense.
- _____ 5. The Defendant shall make restitution or reparation to the victim of his or her conduct for the damage or injury which was sustained, and the Defendant shall pay all Court costs and fines as determined by the court.
- _____ 6. The Defendant shall obtain counseling or treatment for drug abuse, alcohol abuse, or mental condition and shall remain in a specified residential treatment facility if necessary for that purpose, as required by the court. The Defendant may be responsible for the cost of the treatment program.
- _____ 7. The Defendant shall successfully complete all useful public service as ordered by the Court, within the time period determined by the court. The Defendant shall file with the Court Clerk completion of the community service.
- _____ 8. The Defendant shall comply with any other requirements imposed by the court.
- _____ 9. The Defendant will provide the Court with a current mailing and physical address and will immediately notify the Court of any change of address or employment.

_____ 10. The Defendant agrees to service by US mail of all court pleadings including contempt citations, probation revocation and/or other notices. Further, the Defendant waives his or her right to have personnel service of any court pleadings including contempt citations, probation revocation and or other notices.

_____ 11. The Defendant shall answer all reasonable inquiries by the Court.

_____ 12. The Defendant shall comply with any other requirements of probation in order to meet the conditions imposed by the court.

I have read and understand the conditions of unsupervised probation through the Fruita Municipal Court. I understand that any violation of any of the above conditions of probation and/or the courts' order will result in a revocation of probation. I understand that, if my probation is revoked, and/or if I am found in contempt of the courts' order, that I will be sentenced and subject to the original penalty previously advised.
