ORDINANCE 2008-13

AN ORDINANCE ANNEXING TO THE CITY OF FRUITA CERTAIN REAL PROPERTY CONTIGUOUS THERETO RIVER RIM LAKE ESTATES ANNEXATION (Formerly known as Legacy Estates Annexation)

WHEREAS, the Fruita City Council finds that it is necessary to annex certain real property contiguous to the City of Fruita in order to:

- 1. Promote the public health, safety, and welfare of the community; and,
- 2. Insure efficient provision of municipal services and fair and equitable distribution of cost amongst those who use services provided by the community; and,
- 3. Provide for orderly growth of the community; and,

WHEREAS, the City Council adopted Resolution 2006-32 finding that the real property described and shown on Exhibit A is eligible for annexation pursuant to C.R.S. 31-12-106(2), stating their intent to annex same and initiating the annexation procedures:

THE CITY OF FRUITA HEREBY ORDAINS:

<u>Section 1</u>: The Fruita City Council, having reviewed a properly constituted petition of all the owners of real property in the area proposed for annexation, hereby annexes the property as described and shown in Exhibit A attached hereto, and the Fruita City limits are hereby modified to reflect said annexation.

Section 2: Conditions of said annexation include:

Zoning of said property, which shall be established by future public hearing which will be held within ninety days (90) of the effective day of this ordinance.

RIVER RIM LAKE ESTATES (Formerly Known As LEGACY ESTATES) Annexation

Parcel 4: The SE1/4SE1/4 of Section 20, Township 1 North, Range 2 West of the Ute Meridian, Except beginning at the Southeast Corner of said Section 20, Thence South 89°55'49" West 171.60 feet, Thence North 26°27'12" West 227.11 feet, Thence North 41°37'12" East 415.00 feet, Thence North 00°19'12" East 69.17 feet, Thence North 90°00' West 562.74 feet to a fence, Thence North 48°06'30" West 111.35 feet along a fence line, Thence South 89°49'48" West 195.79 feet along a fence line, Thence North 03°40'10" West 171.95 feet along a fence line, Thence South 89°35'23" West 461.91 feet along a fence line to the West line of the SE1/4SE1/4 of said Section 20, Thence North 00°23'03" East 491.90 feet along the West line of the SE1/4SE1/4 of said Section 20, Thence North 89°52'36" East 1315.14 feet along the North line of the SE1/4SE1/4 of said Section 20, Thence South to the Point of Beginning.

Parcel 5: Commencing at the Northeast Corner of Section 29, Township 1 North, Range 2 West of the Ute Meridian, Thence South 89°56' West along the North line of said Section 29 1337.80 feet to the True Point of Beginning, Thence continuing along said North line South 89°56' West 1494.88 feet to the thread of the Colorado River, thence south 54°20' East along said thread 1358.26 feet, Thence North 56°02 East 285 feet, Thence North 48°03' East along a fence 173.70 feet, Thence North 0°52' East along a fence 518.50 feet to the Point of Beginning.
