### Ordinance 2009-04

AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF FRUITA TO REZONE THE LOWER VALLEY FIRE PROTECTION DISTRICT PROPERTY LOCATED BETWEEN MESA AND MULBERRY STREETS SOUTH OF PABOR AVENUE FROM A DOWNTOWN COMMERCIAL RESIDENTIAL DESIGN (DCRD) ZONE TO COMMUNITY SERVICES RECREATIONAL (CSR) ZONE (Project #2009-05)

**WHEREAS,** the subject property is shown and described in attached Exhibit A, incorporated herein by this reference, and

**WHEREAS,** the Fruita Community Plan supports a institutional and civic uses in the downtown area in which the subject property is located, and

**WHEREAS,** the City Council received an application from the property owners, Lower Valley Fire Protection District, to rezone the subject property from DCRD to CSR, and

WHEREAS, at their February 10, 2009, public hearing, the Fruita Planning Commission recommended approval of the application to zone the subject property CSR to the Fruita City Council, and

**WHEREAS,** a public hearing was held by the City Council on March 3, 2009, and

WHEREAS, based on the evidence, testimony, exhibits, study of the City's Master Plan, staff reports including review comments, Planning Commission public hearing minutes, and comments from all interested parties, the City Council finds as follows:

- A. Proper publication and other public notices were provided as required by law for the hearings before the Planning Commission and City Council.
- B. Pursuant to Section 17.13.060 of the Fruita Land Use Code (2004, as amended) the City Council finds that the proposed CSR zone is supported by the city's Master Plan and meets approval criteria that must be considered for rezoning.

### NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FRUITA, COLORADO:

**THAT** the Official Zoning Map adopted pursuant to Section 17.13.060 of the Fruita Land Use Code (2004, as amended) is hereby amended and that the subject property shown and described on the attached Exhibit A, containing approximately 0.64 acre, is hereby rezoned from DCRD to CSR.
