THAT the required subdivision improvements for the Red Cliffs Mobile Home Village #2 Subdivision, Phases 2 and 3are approved for 1st release of the subdivision improvements agreement, subject to 10% of the total cost of improvements being retained for the required two-year warranty period as required by the subdivision improvements agreement.
