A RESOLUTION AMENDING THE 2020 ANNUAL BUDGET WITH A SUPPLEMENTAL APPROPRIATION OF FUNDS FOR COMPLETION OF PROJECTS INITIALLY BUDGETED FOR IN THE 2020 ANNUAL BUDGET AND NEWAPPROPRIATONS FOR OUTDOOR SPACES, SCULPTURES AND SMALL BUSINESS ASSISTANCE
