Coronavirus Update

- Weekly COVID-19 Update from MCPH. As always, below are a few highlights from the weekly COVID-19 update from Mesa County Public Health (MCPH). The full report can be found here.
- School Guidance -
- MCPH worked in coordination with Mesa County Valley School District 51 (D51) on their <u>Keeping Schools Open plan</u> for the 2021-2022 school year.
- MCPH continues to work in collaboration with D51 to identify illness swiftly and take appropriate measures to slow the spread of illness, as well as monitor illness community-wide and make adjustments if needed. The plan remains flexible.
- Delta Variant Spread -
 - There are 836 cases of Delta variant in Mesa County
 - There were 634 reported last week, an increase of 202.
 - MCPH estimates that the total number of Delta variant cases to be much higher, because not all positive tests are tested again for variants.
 - Available vaccines reduce severe illness, including hospitalization and death, associated with all COVID-19 strains, including emerging variants.
- Vaccination Efforts
- Vaccines are Free.
 - The Community Vaccination Site, located at 510 29 ½ Road, accepts walk-ins for COVID-19 vaccine.

Transportation Circulation Plan and Fremont Street Design – Open Houses (Continued)

Another reminder, next Friday and Saturday (July 30-31) we will be hosting two open houses to receive public feedback on the Transportation Active Circulation Plan and the Fremont Street Design at Hwy 6&50. Friday night (between 5:30 p.m. - 8:00 p.m.) we will be at Civic Center Park and then at the Fruita Farmers Market Saturday morning (8:30 a.m. to 12:00 p.m.). As always, residents are welcome to drop in/put any time and share their feedback on the proposed plan and design. General Updates

- Meeting with Governor Polis. Mayor Pro Tem Buck represented the City at a roundtable discussion with Mesa County communities and Governor Polis today. The topic was on vaccination rates in Mesa County and efforts Mesa County Public Health Department is doing regarding awareness and availability.
- Meeting with Secretary Haaland, Governor Polis, Senator Bennet, Senator Hickenlooper,
 Congressman Neguse and Congresswoman Boebert. I was able to represent the City at a
 roundtable discussion with area colleagues to express our support and reasonings for the BLM
 headquarters and decision makers to continue being located in Grand Junction. I was able to
 share about our strong, long-term partnerships and alignment of goals with our public lands
 agencies.
- **Meeting with Senator Hickenlooper's State Director.** I was able to join my colleagues with GJ and Palisade to share big picture needs in our area of a federal nature, and our priorities as a community with Senator Hickenlooper's staff.
- *RFP for Marketing Services.* We released a request for proposals for tourism and promotion services this week and will be accepting them through August 20th at 5pm. More info can be found here.
- OPIOID Settlement Governance Board. The Attorney General's office is settling with one of the
 four pharmaceutical companies they sued re: opioids, and he plans to share some of those funds
 with counties, cities and also in regional areas. 60% of the funds will be distributed through the

- regions. Mesa County is its own region, and it is <u>estimated</u> that Mesa's Region should receive about \$450K a year for 18 years from the first company. A governance board of required governmental members and healthcare partners has been created and I will be representing Fruita on this board and participating in monthly meetings.
- Team Imondi Wake Zone Going to WWA Park National Championships. Congratulations to the Imondi Wake Zone team heading to the National Championships! 14 Imondi Wake Zone wakeboarders have qualified and will be traveling to Florida in early August. Good luck!
- Town of Palisade Invites Community to Celebrate the Completion of the Palisade Plunge. This afternoon, the Town of Palisde, COBMOBA, Mesa County, and other partners hosted a ribbon cutting event for the full Palisade Plunge. Congratulations to Palisade and all partners on the opening of the trail! It is going to be a tremendous asset to our community. If you are interested in attending, the Town of Palisade has invited the community to a celebration in Palisade tonight from 5:00-9:00 p.m. in downtown Palisade.
- Update form CDOT on I-70 Closures. Today, CDOT released the following: CDOT maintenance crews continue to work diligently to reopen Interstate 70 in Glenwood Canyon after several debris flows occurred Thursday evening. I-70 continues to be closed in both directions between Exit 116 (Glenwood Springs) and Exit 133 (Dotsero), with an additional closure point at Exit 87 (West Rifle). The safety closure is necessary to protect the traveling public. Crews are working on two major impacts today in order to reopen I-70. The first is to create a safety barrier to protect the interstate wall along eastbound lanes at Mile Point 124. The Colorado River is flowing along the wall and recreation path due to a debris field blocking the river nearby. Crews are also clearing a box culvert further east on I-70, at MP 129. The box culvert is full of material, preventing floodwaters from draining from east and westbound lanes. The box culvert must be cleared and drained before floodwaters can be cleared and before crews can clean east and westbound lanes. If there is more rain this afternoon, it could significantly overwhelm the box culvert and further delay reopening the interstate. On Wednesday, CDOT released this press release on closures on I-70: Travelers should prepare for weather-related disruptions and road closures through at least next week. These closures are due to ongoing flash flood watches and warnings due to monsoon rains that are likely. If you are traveling on I-70 soon, you can find the latest closures on CDOT's website.
- **Update from Mesa County on Property Taxes.** This week, the Mesa County Treasurer released an update on past due taxes for mobile homeowners. The Treasurer is encouraging anyone with past due notices to reach out to them to avoid costly fees. The full release can be found at this link.
- Mesa County Honors Late Human Services Executive Director. Next Monday, Mesa County is proclaiming July 26, 2021, as Tracey Garchar Day. Mesa County will be hosting an event at the Department of Human Services honoring Tracey Garchar and dedicating the lobby of the building to him. If you are interested in attending, more information can be found here, and events will take place on Monday afternoon at 4:00 p.m. Tracey Garchar was the Director of Human Services and spent 23 years working in the field. From Mesa County: "Tracey Garchar was a one-of-a-kind leader, visionary, mentor and friend. He leaves behind a legacy of values he

- lived by every day, which he instilled in his team to carry on: humanity, balance, honesty, inclusion and teamwork."

- Mesa County Chip Seal Project Update. For July 26 July 30, the Mesa County Chip Seal project will take place at the following four locations: US Highway 6 from Mile Point 11 to MP 20, CO Highway 139 from MP 0 to MP 6, US 50 Frontage Road from MP 33.8 to MP 36.2 and CO 141 from MP 120 to MP 154. For next week, motorists should plan for north and southbound closures on US 50 Frontage Road, Tuesday through Thursday lane closures on US 6, and north and southbound mobile lane closures on Friday for CO 139. - Aspen Ave. And Maple St. have been striped with pavement markings this week and are open.
- Wildcat Ave. is closed along the east side of the Fruita 8/9 school for construction related to Grand Valley Estates Subdivision. The plan is to have the road open prior to the beginning of school.





Stage 1 Fire Restrictions Fact Sheet









Fires in permanent fire pits, fire rings at private residences or within developed recreational sites such as a campground, or picnic area.





Fire features, chimineas and tiki torches at private residences supervised by a responsible adult.





Fires contained within liquid fueled or gas fueled stoves, lanterns, or heating devices.



Agricultural burns with SHERIFF'S OFFICE ISSUED PERMIT ONLY! Mesa County Fire Marshal will do a safety inspection prior to issuing permit.

Only PERMITTED PROFESSIONAL FIREWORKS displays are allowed.



NOT Allowed





The personal use of all fireworks are prohibited during fire restrictions.





Any fire or campfire, not within a permanently constructed fire grate in a developed park, campground, private residence, or picnic area.



Smoking, EXCEPT within an enclosed vehicle or building, a developed recreation site, or while stopped in an area of at least six feet diameter that is barren or cleared of all combustible material.

Operating or using any internal combustion engine, such as chainsaws, without a spark-arresting device properly installed, maintained, and in effective working order.





Welding or operating acetylene or other torch with open flame EXCEPT in cleared areas of at least 10 ft in diameter and in possession of a chemical pressurized fire extinguisher.

Target shooting with explosive targets is not permitted.
